

**SUMMARY ANNUAL REPORT**

This is a summary of the annual report of the TRACE SYSTEMS INC. EMPLOYEE BENEFITS PLAN, EIN 22-3684941, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

TRACE SYSTEMS INC. has committed itself to pay certain self-insured claims incurred under the terms of the plan.

**Insurance Information**

The plan has contracts with DELAWARE AMERICAN LIFE INSURANCE COMPANY, UNITEDHEALTHCARE INSURANCE COMPANY, HAWAII MEDICAL SERVICE ASSOCIATION, MUTUAL OF OMAHA LIFE INSURANCE COMPANY, CIGNA HEALTH AND LIFE INSURANCE COMPANY and UNITED OF OMAHA LIFE INSURANCE COMPANY to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, and Business Travel Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$4,150,291.
